Jim said that we have \$13,000 in the checking account and an overall total of \$27,000. We should as a first step to take \$5,000 and reinvest that in the endowment account.

- Brad suggested Lina do the shorebird Survey update summary

Lina stated the statistics were up and down, with a Black Skimmer colony of approx. 150, at first; but, after then, not many were noted (at most 15). Winter shorebirds that were counted included: Sanderlings, Western Sandpipers and other Sandpipers and Plovers, plus terns. FGCU students are helping survey by spot checking with photos. There are 2-3 volunteers that are especially good.

Jim: Would like ASWF to reimburse shorebird stewards for parking costs and associated fees. Motion by Brad and 2nd by Sean-Approved.

RCC update-Brad:

There is going to be shorebird training by Rochelle Stecker for ½ time stewards in Lee and Collier Counties, at the end of April had meeting-Anchor Steward positions are open. Budget cuts are happening at Corkscrew Sanctuary because of Covid related lack of revenue; they are doing a capital raising campaign

- Gerri & Brad: AF's SW Florida Regional Resiliency Compact

Notes re: Compact: Sign-ons up to 10; meetings with two Fort Myers City Council members; Lee County Commission has Compact on agenda for March 16; City of FM hiring an environmental consultant subsequent to DEP fines

Lee County Commission voted to join the Resiliency Compact; There is a desire from Sanibel leadership to be unified to get more funding for desired projects. Gerri and three reps of Florida Audubon, Halle, Laura, met with two Fort Myers councilmembers and it was encouraging; Total is eleven sign-ons, Collier County is yet to schedule a vote. Gerri is working on a letter to request a letter of support from Sen. Rodrigues for the Fort Myers Mayor and Council.

- Gerri: Sent comments in support of Florida Fish and Wildlife Conservation Commission's new rules on nonnative invasive reptiles

City of Fort Myers to hire environmental consultant

***Endowment Fund** (LPL Investments): A long-term objective relating to the endowment fund has been to restore it to its permanently endowed balances of over a decade ago, which were then in excess of \$100k (currently at \$79k).

As there is a surplus of cash within our non-income producing 5/3rd checking account (current balance about \$14k), Jim suggests the chapter:

1) transfer \$5k to the LPL investment account so it begins earning income; and, 2) make a bookkeeping entry within LPL to transfer \$5k from “available” to “permanently endowed.” This still leaves over \$13k of “available” funds within LPL, begins to reimburse the endowment fund, and produces a bit more “available” income, all while preserving the primary function of the endowment fund to fully fund our annual FGCU scholarship with the fund's earnings (never the principal).
